Ken will be encouraging Young Ambassadors to work with SACRE on producing a leaflet.

Pupil voice will be a feature of the consultation for the review of the Agreed Syllabus.

Ken discussed current and future CPD opportunities including secondary RE network, primary network, Better RE – a course run by Lat Blaylock on 23 January 2014, annual SACRE conference to be held on 26 June 2014.
