It was also noted that the OFSTED Report on Transforming RE 2006- 2009 (part of agenda item 7) contained criticism on the level of support by LA's to SACRE. The Chair said that all ought to know more of the work of SACRE.

The point was raised that Councillors were not attending the meetings of SACRE and the Chair responded that he will talk to the other members. **ACTION by Chair** 

The meeting also raised concerns over the lack of inspection for RE and that teachers are having to work together as there is no official support from the Authority, In response it was stated that inspections only happen in core subjects and there was no funding available. It was also pointed out, that RE was the only subject that the County Council has responsibility for, something it does not have for other subjects and there needs to be a level of commitment. Hilary mentioned that a paper was to go to Schools forum to support the work of the RSResource Centre in offering support for all County Schools. John Morris picks up queries form Primary Schools.

Cllr Allen Clarke said that there was a need to ask for more support.

There was a growth of teachers asking for training on how to approach RE and those with capability could be asked to run training events in local schools for part days, however there were cost implications in this.
